A-1 Approval of Chester Charter School for the Arts' amendment of their charter

WHEREAS, the Chester Charter School for the Arts ("CCSA") made application to the Chester Upland School District ("the District") for a charter to operate a charter school in the school district.

WHEREAS, the Chester Charter School for the Arts was issued a charter pursuant to the application by the Charter Appeal Board on August 22, 2012; and

WHEREAS, the charter issued to CCSA authorized it to operate a K-12 elementary and secondary school; and

WHEREAS, on July 18, 2013 an amendment was approved to the Charter; an

WHEREAS, a resolution of intent was approved by the Receiver for the District on August 21, 2014

NOW THEREFORE, BE IT RESOLVED that the charter of the Chester Charter School of the Arts is amended to extend the term of the charter for a period of five (5) years from November 12, 2014 and ending November 11, 2019.

FURTHER RESOLVED, that the resolution of July 18, 2013 agenda item A-8 is hereby revoked.
